 - (c) to "councillors" were references to "committee members".
- (2) The members of a committee may elect a deputy presiding member from amongst themselves but any such election is to be in accordance with Schedule 2.3, Division 2 as if the references in that Schedule—
 - (a) to "office" were references to "office of deputy presiding member"; and
 - (b) to "council" were references to "committee"; and
 - (c) to "councillors" were references to "committee members"; and
 - (d) to "mayor or president" were references to "presiding member".

Once the Committee have elected their Presiding Member, the Governance Officer will hand the meeting over to them.

One nomination was received from Councillor JM Stratford for the position of Presiding Member. As no other nominations were received, Councillor JM Stratford was declared elected.
