# RESTRICTED ACCESS VEHICLE (RAV) NETWORK ACCESS – SHIRE STAFF RESEARCH REQUEST

Transport operators or farmers planning to use Restricted Access Vehicles (RAVs), such as Road Trains, B-Doubles and Truck & Dog Trailer combinations to complete any transport task, must first ensure the required public roads are approved for the appropriate RAV network.

As the sole authority to approve or decline RAV access, Main Roads Heavy Vehicle Services (HVS) is responsible for administering RAV access on all public roads in the State, which includes carrying out a thorough route assessment process to determine if roads are safe and suitable for RAV access.

Using the RAV Mapping Tool on the Main Roads website at [www.mainroads.wa.gov.au](http://www.mainroads.wa.gov.au) is the simplest way to identify the approved RAV Network and access conditions (if applicable) for a particular road.

If the road required is not approved, transport operators or farmers can apply to HVS (Heavy Vehicle Helpdesk on 138 486 or email [hvs@mainroads.wa.gov.au](mailto:hvs@mainroads.wa.gov.au)) to have it assessed for addition to the relevant RAV Network.

Whilst acknowledging this individual ‘case-by-case’ application process remains open to transport operators or farmers, Shire staff are undertaking research to determine whether a more strategic approach to establishing a fit-for-purpose Shire-wide RAV network may prove beneficial for stakeholders involved in completing local grain freight transport tasks.

To assist in this research, Shire staff would welcome nominations of Shire roads that transport operators or farmers would like to see added to the relevant RAV network that would lead to improvements to the local grain freight transport task.

As stated above, specific applications are made to HVS so it should be noted that any nominations are for research purposes to assist in developing a strategic framework for Council to use when considering any changes to the RAV network.
